# Q1: growth continues, guidance confirmed, BUY

## What's it all about?

Deutsche Rohstoff reported a robust first quarter with revenues up 30% year on year, driven by a 37% increase in BOE production despite a slight decline in average realized WTI prices. The company plans to bring 15 net wells on stream for the full year. EBITDA margins were stable year on year. While Q1 CFO was slightly lower than last year, Deutsche Rohstoff aims to fund its full year capital expenditure budget from current cash flow and existing liquidity. The company confirms its base guidance for FY24. The attractive shareholder remuneration in the form of the recently proposed dividend and the share buyback programme, with a combined yield of 5.8%, should act as a catalyst to narrow the valuation gap to peers. We reiterate our BUY recommendation with an unchanged price target of EUR 56.70.

## Q1: growth continues, guidance confirmed, BUY

**Q1 revenue grows 30% yoy.** Deutsche Rohstoff has announced its Q1 figures. Revenues were up 30% yoy, driven by a 37% increase in BOE production, while the average realized WTI price was down 2% and the realized gas price was down 42%. The strong production reflects the continued good development of new wells in Wyoming. Sequentially, production was down 5% from the record Q4 23, which was boosted by 9 wells brought on stream last autumn. For the full year 2024, Deutsche Rohstoff plans to bring 15 net (economic interest) wells into production.

**Stable EBITDA margin**. The Q1 EBITDA margin of 74.9% was in line with Q1 23 (75.7%). While opex per BOE declined by around 7% in USD terms, this potential margin improvement was offset by a disproportionate increase in personnel expenses, mainly due to the insourcing of infrastructure services, and lower other operating income from the sale of securities. Depreciation per BOE increased by almost 22% yoy to USD 15.47, exceeding our expectations and we adjust our estimates accordingly, leading to a lower EBIT.

**Slightly negative FCF**. Q1 CFO of EUR 36.3m was slightly lower than last year, mainly due to a reduction in trade payables, probably a timing issue. Excluding this effect, CFO was sufficient to fund Q1 investments. For the rest of the year, Deutsche Rohstoff expects to finance the investment budget of EUR 145m to EUR 165m (mwb est. EUR 153m) from current cash flow and existing liquidity of EUR 63m.

**Guidance confirmed; valuation remains attractive; BUY**. Deutsche Rohstoff confirmed its FY24 guidance based on WTI USD 75.00: Revenues are expected to be in the range of EUR 210m to EUR 230m and EBITDA in the range of EUR 160m to EUR 180m. Deutsche Rohstoff's discount to US peers remains above 50% on the basis of EV/EBITDA 24E. The attractive shareholder remuneration in the form of the recently proposed dividend and the share buyback programme, with a combined yield of 5.8%, should act as a catalyst to narrow the valuation gap. We reiterate our BUY recommendation with an unchanged price target of EUR 56.70.





## Valuation

## **DCF Model**

The DCF model results in a fair value of EUR 56.75 per share:

**Top-line growth**: We expect Deutsche Rohstoff AG to grow revenues at a CAGR of - 2.6% between 2024E and 2031E. The long-term growth rate is set at -10.0%.

ROCE. Returns on capital are developing from 22.1% in 2024E to 10.4% in 2031E.

**WACC**. Starting point is a historical equity beta of 0.56. Unleverering and correcting for mean reversion yields an asset beta of 1.09. Combined with a risk-free rate of 2.0% and an equity risk premium of 6.0% this yields cost of equity of 11.0%. With pre-tax cost of borrowing at 7.5%, a tax rate of 25.0% and target debt/equity of 0.5 this results in a long-term WACC of 9.2%.

## FCF Yield Model

Due to the fact that companies rarely bear sufficient resemblance to peers in terms of geographical exposure, size or competitive strength and in order to adjust for the pitfalls of weak long-term visibility, an Adjusted Free Cash Flow analysis (Adjusted FCF) has been conducted.

## The adjusted Free Cash Flow Yield results in a fair value between EUR 138.95 per share based on 2024E and EUR 150.33 per share on 2028E estimates.

The main driver of this model is the level of return available to a controlling investor, influenced by the cost of that investors' capital (opportunity costs) and the purchase price – in this case the enterprise value of the company. Here, the adjusted FCF yield is used as a proxy for the required return and is defined as EBITDA less minority interest, taxes and investments required to maintain existing assets (maintenance capex).


Simply put, the model assumes that investors require companies to generate a minimum return on the investor's purchase price. The required after-tax return equals the model's hurdle rate of 6.0%. Anything less suggests the stock is expensive; anything more suggests the stock is cheap. **ESG adjustments might be** applicable. A high score indicates high awareness for environmental, social or governance issues and thus might lower the overall risk an investment in the company might carry. A low score on the contrary might increase the risk of an investment and might therefore trigger a higher required hurdle rate.



## Peer group analysis

A peer group or comparable company ("comps") analysis is a methodology that calculates a company's relative value – how much it should be worth based on how it compares to other similar companies. Given that **Deutsche Rohstoff AG** differs quite significantly in terms of size, focus, financial health and growth trajectory, we regard our peer group analysis merely as a support for other valuation methods. The peer group of Deutsche Rohstoff AG consists of the stocks displayed in the chart below. As of 14 May 2024 the median market cap of the peer group was EUR 18,179.4m, compared to EUR 218.2m for Deutsche Rohstoff AG. In the period under review, the peer group was less profitable than Deutsche Rohstoff AG. The expectations for sales growth are higher for the peer group than for Deutsche Rohstoff AG.

### Peer Group – Key data





Comparable company analysis operates under the assumption that similar companies will have similar valuation multiples. We use the following multiples: EV/EBITDA 2024, EV/EBITDA 2025, EV/EBIT 2024, EV/EBIT 2025, P/E 2024 and P/E 2025.

## Applying these to Deutsche Rohstoff AG results in a range of fair values from EUR 82.10 to EUR 142.21.



## Risk

The chart displays the **distribution of daily returns of Deutsche Rohstoff AG** over the last 3 years, compared to the same distribution for Occidental Petroleum Corp. We have also included the distribution for the index MDAX. The distribution gives a better understanding of risk than measures like volatility, which assume that log returns are normally distributed. In reality, they are skewed (down moves are larger) and have fat tails (large moves occur more often than predicted). Also, volatility treats up and down moves the same, while investors are more worried about down moves. For Deutsche Rohstoff AG, the worst day during the past 3 years was 26/11/2021 with a share price decline of -14.1%. The best day was 16/09/2021 when the share price increased by 10.5%.





### Sales vs. EBITDA margin development






ROCE vs. WACC (pre tax)





Capex & chgn in w/c requirements in EURm
